To qualify, you must obtain a certificate of residence issued by your home county. If you do not file this form with the County by thirty (30) days after the start of classes, you will be charged out-of- state (non-resident) tuition. You must obtain the certificate of residence no more than sixty (60) days prior to registering for the semester/term in which you are utilizing the certificate for. A certificate of residence is valid for one (1) year from the date of issuance and will be valid for every term that commences within that one year. You must obtain another certificate of residence after it expires through this same process.
